## **NOTIFICATION**

In pursuance of Finance Department Notification No.9099-F dated 23.09.2009 read with 9568-F(y) dated 21.10.2009; the issue of ante-dating of scale promotion under CAS/MCAS has been under processing in this department.

Before aforesaid drawals, an undertaking shall also have to be =obtained from officers / retired officers concerned to the effect that he / she will be liable to refund the amount drawn in excess, if any such excess drawl is detected later on, in a single instalment.

## No arrear will be given up to 28.02.2001 in respect of the said Officers.
